- Issuance of Debt Securities by the **Province of Córdoba** totaling **US\$1,525,000,000** (**US\$725,000,000** in July 2025 and **US\$800,000,000** in February 2026) to finance the repurchase of debt securities maturing in 2027, infrastructure projects, and/or the repayment of existing debt
- **Province of Córdoba US\$1,669,405,000** consent solicitation and debt restructuring
- **SCC Power** acquisition of four power generation facilities from **Stoneway Capital Corporation** as part of the latter's **US\$527,861,000** Chapter 11 process

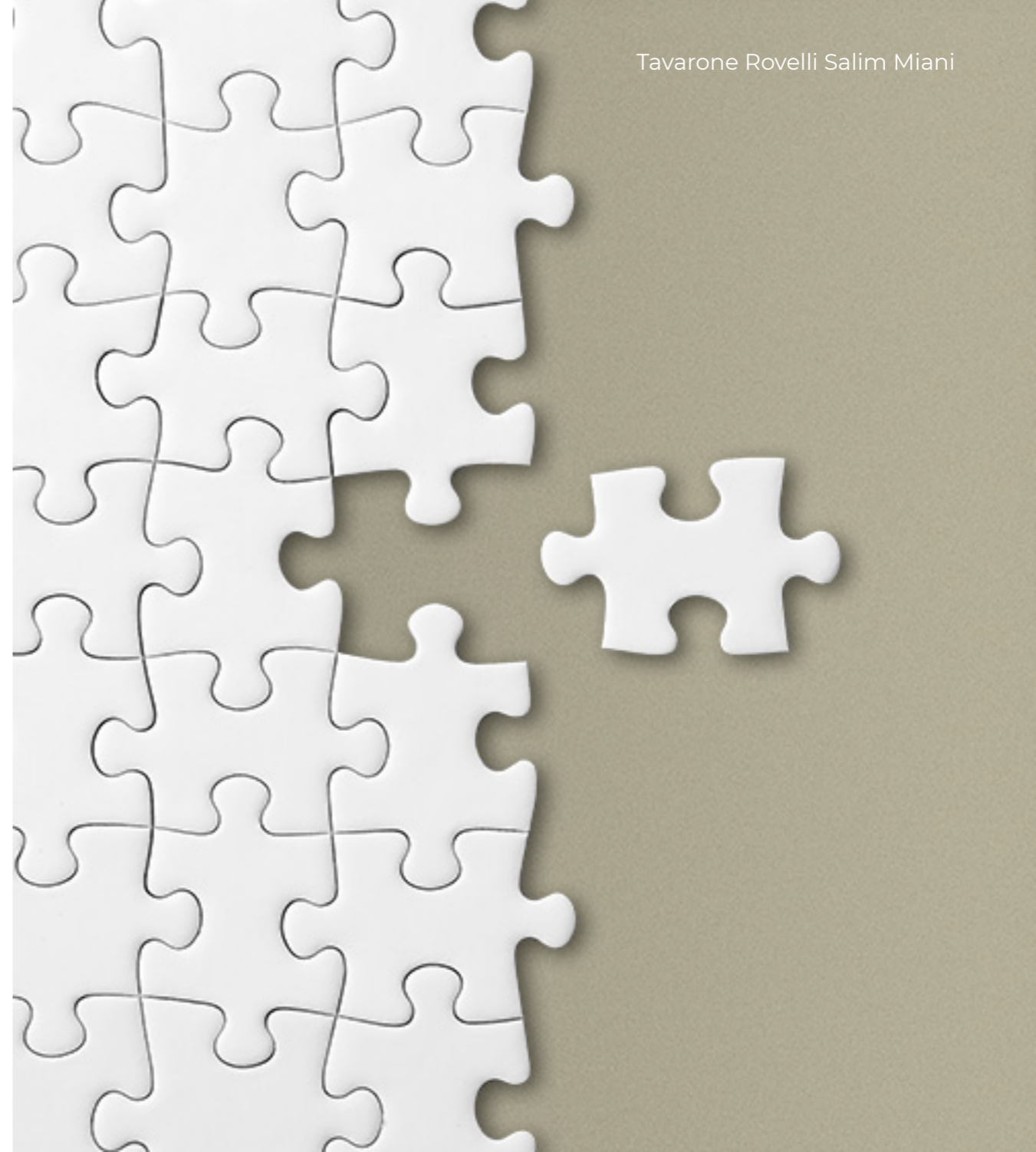

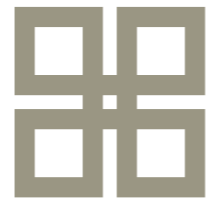
